Foster understands and agrees that food will be provided by TLF and agrees to give ample notification to TLF when additional food is needed. Foster agrees to provide the dog/puppy/kitten(s) with adequate care, food, clean water and shelter. TLF provides all necessary supplies needed for each foster. Should the Foster choose to purchase specialty items, treats, clothes, collars, for the foster animal those costs are NOT covered by TLF. \_\_\_\_\_

Foster understands and agrees that in the event the dog/puppy/kitten(s) needs medical attention the Foster is to contact TLF for instructions. The Foster is not authorized to take the dog/puppy/kitten(s) to any vet without prior permission from TLF. The Foster will be responsible for any and all cost incurred if TLF is not contacted first and you are given pre-authorization. \_\_\_\_\_

Foster understands and agrees that the dog/puppy/kitten(s) must at all times wear a collar and tag with TLF'S information. \_\_\_\_\_

Foster understands and agrees to notify TLF immediately in the event the dog/puppy/kitten(s) gets loose or is missing. \_\_\_\_\_

Foster understands and agrees to bring the dog/puppy/kitten(s) to our adoption events on Saturdays and Sundays (Drop off and pickup times are as follows: Sat. and Sun 11:00am drop off 5:00pm pickup (Winter hours) 6:00pm pickup (Summer Hours). Occasionally we schedule events at other locations, those dates times and locations will provided to you as they are scheduled. \_\_\_\_\_

Foster understands and agrees that they are not to move to dog/puppy/kitten(s) out of the home into another home for any reason unless prior permission is given by TLF. \_\_\_\_\_

Foster understands and agrees to give TLF at least three weeks notice of upcoming vacations or scheduled out of town events to give TLF ample time to arrange boarding of the dog/puppy/kitten(s) . Fostering is a commitment from start to adoption unless previously arranged with TLF. \_\_\_\_\_

Foster understands and agrees that TLF makes no representations or warranties concerning the health, temperament and/or behavior of the dog/puppy/kitten(s) and the first week in a foster home is a lot about decompression and cleansing of the past and achieving true health. TLF gives you all of the medical support to do this responsibly and correctly. \_\_\_\_\_

Foster understands and agrees that if they choose to adopt the dog/puppy/kitten(s) they will be required to submit an adoption application and sign a contract with TLF. Furthermore, the Foster will be given a discount of \$50.00 on the adoption donation. Fostering does not mean a free dog/puppy/ kitten (s) to a Foster for fostering. TLF is unable to offer a higher discount as we have to cover our expenses on the dog/puppy/kitten(s) which in some cases is higher then the adoption donation. \_\_\_\_\_

**Foster understands and agrees that all work done with TLF is at his/her own risk, and hereby releases TLF, its officers, volunteers, agents, employees, contractors and representatives from any liability of any kind whatsoever arising from his/her voluntary foster care and/or from any claims relating to adoption, ownership or possession of the foster animal. The Foster also agrees to indemnify and hold harmless TLF its officers, volunteers, agents, employees, contractors and representatives from any and all losses, fines, claims or damages, including reasonable attorneys' fees, arising out of or relating to the foster animal or his/her voluntary foster care of such animal, including any claims for injury or damage to persons or property caused by the foster animal.**
